



## Terms and Conditions for Year End 10X Imperium Points Overseas Spend ("Promotion")

- This Promotion is available from 21 November 2024 to 15 February 2025 both dates inclusive and is
  only valid for DCS Imperium World Elite Card ("Card").
- This Promotion is open to all principal DCS Imperium World Elite Cardmembers ("Cardmembers").
- From 21 November 2024 to 15 February 2025, Cardmembers who spend a minimum of \$\$25,000 on Foreign Spend transactions on the Card in that promotion period will earn a bonus 4X Imperium Points (equivalent to 1.6 air miles) on top of the 6X Imperium Points (equivalent to 2.4 air miles) for every dollar spent in transactions that qualify as Foreign Spend.
- The bonus 4X Imperium Points will be awarded to all Foreign Spend after the promotion has ended within 10 working days if cardmembers has achieved \$\$25,000 in Foreign Spend.
- "Foreign Spend" refers to Card retail transaction(s) posted in any currency except for SGD.

- DCS reserves the right to reverse Imperium Points awarded to a Cardmember by debiting the Cardmember's Card account accordingly in the following events: (a) a Card transaction (in full or in part) is cancelled or reversed by any party for any reason; (b) the Imperium Points awarded to a Cardmember exceeds the overall cap of 2 million Imperium Points; and/or (c) It is determined by DCS that the Cardmember has breached one of the terms stated herein.
- The Imperium Points earned under this Promotion are not transferable and/or exchangeable for other goods and services, other than those determined by DCS.
- If the Cardmember terminates the Card account, any accumulated Imperium Points will be forfeited.
   DCS reserves the right to reverse Imperium Points awarded to a Cardmember in the event of any refunded, disputed, unauthorised or fraudulent retail purchases as well as Goods and Services Tax (GST) that were charged to the Card.

- Cardmember in respect of any transaction due to any reason whatsoever or howsoever (including but not limited to the incorrect classification of category in respect of any transaction).
